Typical Processing

- 1. Use at a level of 3 10.0% (depending on load of soil in system) by volume to flush and clean system. Time: Circulate well. Allow 1/2 - 4 hours to effectively remove contaminants.
- 2. Temperature: ambient -140 F. is preferred. (or as needed in system)
- 3. Run filters and overflow mechanisms while processing purge.
- 4. Rinse system well with water.
